Who We Are

The 4 C's

Sun Devil Mock Trial is centered around 4 core values that we call the **4 C's**. These principles encompass everything we do at practice, in the courtroom, and in our community.

Competition

The number one goal of SDMT is to bring home a national championship trophy: this is the mission that drives us every day, whether that be at practice, tournaments, or anywhere in between. This competitive drive ensures that our competitors are constantly improving their trial advocacy skills, professional bearing, and legal knowledge. Entering the 2025-26 season, ASU A is the highest ranked team ASU has ever fielded, at 45th in the country. Our B team isn't far behind at 66. This standard of excellence on the national stage is what motivates us every day.

Community

SDMT is built on the volunteer efforts of local attorneys, grad students, and judges. Thus, we take pride in the community work and involvement we expect from our undergraduate competitors. Our community gives us so much every year, so we do what we can to help give back. Our members coach high school mock trial teams, volunteer with local government initiatives, and participate in philanthropic internships.

Character

SDMT isn't just focused on inspiring great advocates--we're building great people, too. Our coaches, veteran competitors, and alumni assistants are always working to instill a strong moral compass in each of our competitors. By developing students with unflinching character who treat everyone with respect, we strive to influence the legal community by introducing strong, caring advocates.. Beach Party – Irvine, California

Hosted at the beautiful UC Irvine campus, beach party is one of the most prestigious invitationals in the nation, accepting only the top teams from the top programs. ASU sent our A and B team, and brought home some hardware. **ASU A** claimed **2nd place**, an incredible achievement!



Our first regionals of the year was the Claremont regionals. ASU sent 2 teams to Claremont, and secured our first (but surely not last!) bid to ORCS of 2025. This bid was a monumental achievement, too. ASU F became the first F team in *AMTA history* to get a bid out of regionals! Yes, you read that right, the first F team **ever**. This was a dream start to our competitive run, and we commend **ASU F** on their 6-2 ORCS bid!
